➤ **About IYF:**

The [International Youth Foundation \(IYF\)](#) invests in the extraordinary potential of young people. Founded in 1990, IYF builds and maintains a worldwide community of businesses, governments, and civil society organizations committed to empowering youth to be healthy, productive, and engaged citizens. IYF programs are catalysts of change that help young people obtain a quality education, gain employability skills, make healthy choices, and improve their communities.

Background

IYF is a USA based public charity, tax-exempt under Section 501(c) (3) of the Internal Revenue Code and has been determined by the IRS not to be a private foundation.

IYF’s operating budget is approximately \$20 million, including \$15 million in program grants and contracts. Funding of IYF’s program work is divided between corporations/corporate foundations and government overseas development assistance (ODA) agencies (e.g., US Agency for International Development).

IYF last upgraded its accounting software to Infor Cloud SunSystems in December 2018. Grant records are kept using GIFTS Online, a specialized database program managed by Blackbaud. IYF operates on a calendar fiscal year, ending December 31.

IYF’s headquarters is in Baltimore, Maryland, USA. IYF has fully registered country offices in Ethiopia, Mexico, Palestine and Zimbabwe. The following table delineates the size, staff and transaction levels by location.

- Three ERP Software solutions in order of preference.
- Proposed annual fee, including expenses, for 2025-2029.
- Each bidder is given wide latitude in the degree of detail it elects to offer or extent to which plans, designs, systems, procedures are revealed. However, insufficient detail may result in a determination that the bid proposal is materially non-responsive or may lower its technical score.

Proposals should be submitted to the Controller by **20 November 2024**.
